## **Drug / Alcohol Abuse and Prevention Program**

No student or staff shall distribute, dispense, possess, use or be under the influence of any alcoholic beverage, malt beverage or fortified wine or other intoxication liquor or unlawfully manufacture, distribute, dispense, possess, use or be under the influence of any narcotic drugs, hallucinogenic drug, amphetamine, barbiturate, marijuana, anabolic steroid or any other "controlled substance" before, during or after school hours on any NFTC campus or at NFTC sponsored event, activities or events.

NFTC annually hosts Drug and Alcohol Awareness Programs for students. These programs are open to all students, but may be required for students in violation of this policy as a first level disciplinary sanction.
